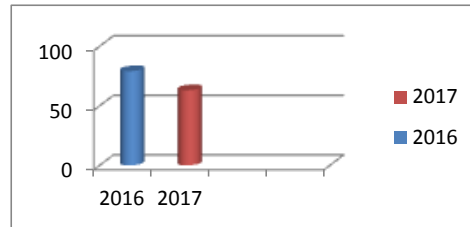
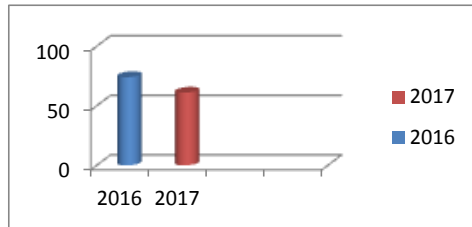


Passaic County Prosecutor's Office Non-Fatal Shooting and Homicide Environment



Paterson Non-Fatal Shootings
2016-74 2017-61 18% DECREASE

Passaic County (all municipalities) Non-Fatal Shootings
2016-79 2017-63 20% DECREASE

From January 1, 2017- December 31, 2017 The City of Paterson has experienced a 18% decrease in non-fatal shootings compared to the same time period in 2016 (61 incidents 2017 vs. 74 incidents 2016).

Passaic County (all municipalities) has experienced an overall decrease of 20% regarding non-fatal shootings from January 1, 2017-December 31, 2017 compared to the same time period in 2016 (63 incidents 2017 vs. 79 incidents 2016).

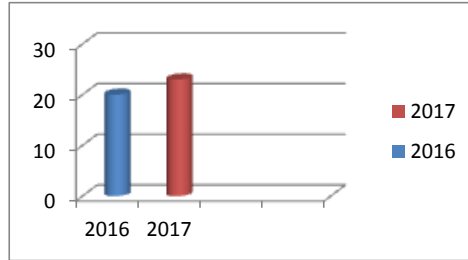
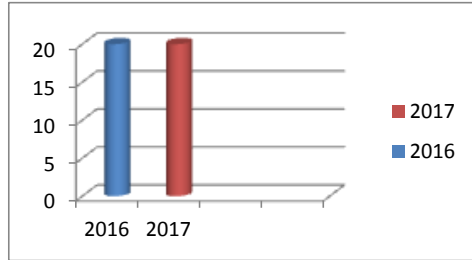
From January 1, 2017- December 31, 2017 there have been 80 non-fatal shooting victims in the City of Paterson. 88% were male vs.12% female (70 male victims vs.10 females) .

From January 1, 2017-December 31, 2017 there have been 82 non-fatal shooting victims in the County of Passaic (80-victims in the City of Paterson and 1-victim in the City of Passaic 1-victim in Hawthorne).

In 2016 (January 1, 2016- December 31, 2016) there were a total of 74 non-fatal shooting incidents in the City of Paterson.

In 2016 (January 1, 2016-December 31, 2016) there were a total of 79 non-fatal shootings in Passaic County. (74-in the City of Paterson, 4-in the City of Passaic, and 1-in Haledon Borough).

From January 1, 2017-December 31, 2017 the City of Paterson experienced no change in homicides compared to the same time period in 2016 (20 incidents 2017 vs.20 incidents 2016).

Passaic County (all municipalities) has experienced an overall increase of 15% regarding homicides from January 1, 2017-December 31, 2017 (23 incidents 2017 vs. 20 incidents 2016).

From January 1, 2017-December 31, 2017 there was one (1) homicide that occurred in Wayne, one (1) homicide that occurred in Ringwood and one (1) homicide that occurred in the City of Passaic.

In 2016 (January 1, 2016-December 31, 2016) there were a total of 20 homicides that occurred in Passaic County all of which occurred in the City of Paterson.

******Note these statistics do not include non-fatal and fatal shootings that involve members of Law Enforcement.***
